

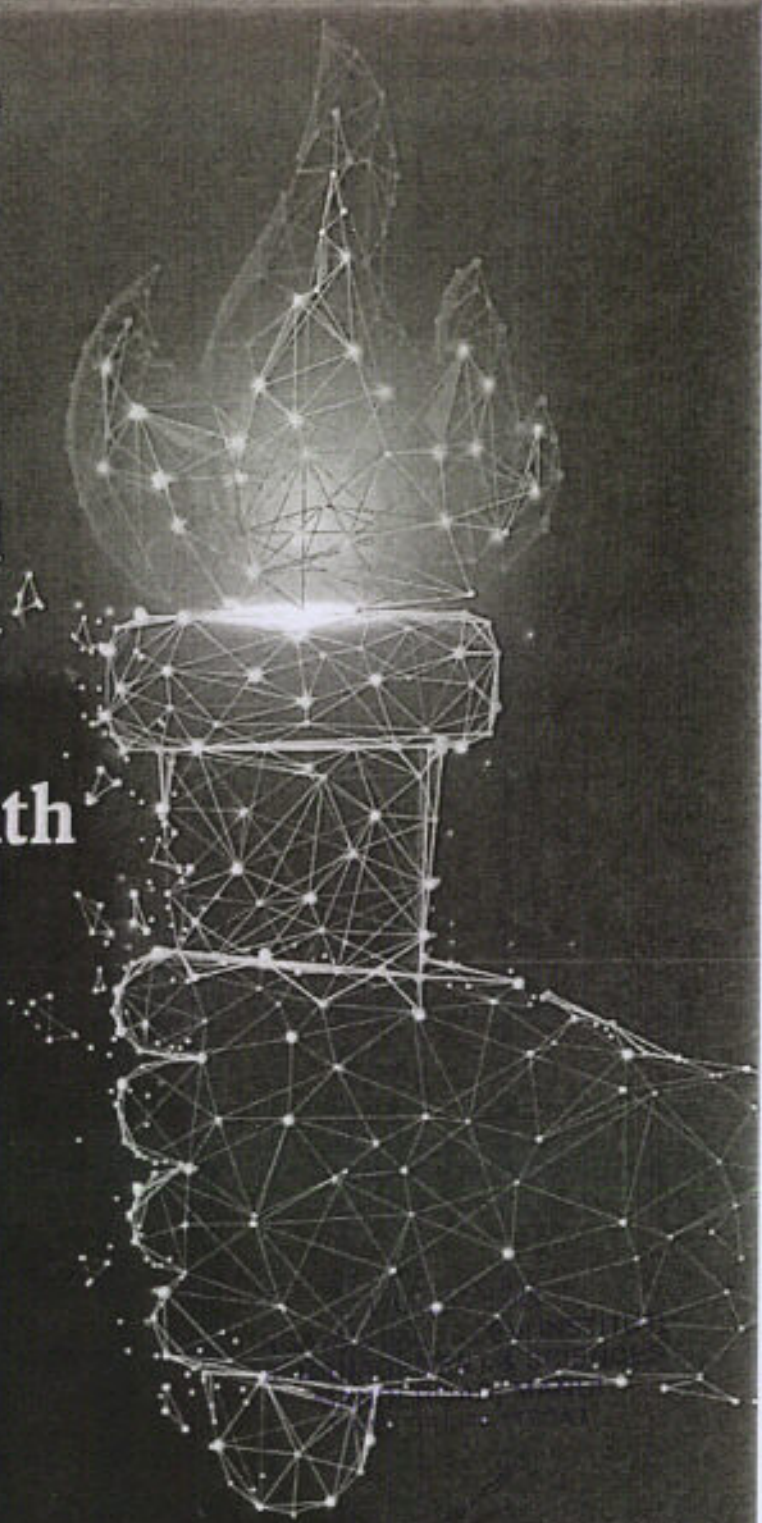

A strange democracy where voices hardly count?



Dissent is a fundamental part of democracy. Voicing dissent is not a crime. Unless we are veering away from democratic norms. And if we are, that is yet another reason why citizens should be rising in protest. **Sakuntala Narasimhan** says she has not joined any protest march or meeting, she is only a bystander and observer, but she has questions that tens of thousands of other Indian citizens are pondering over, seeking answers

As I write (December 20) two persons have been killed in Mangalore during protests against the Citizens Amendment law. Bengaluru has had Section 144 imposed (prohibiting congregation of more than four persons) though hundreds of citizens gathered to voice their protests despite the prohibitory orders; several were arrested by the police. Elsewhere around India, too, people have gathered in large numbers to voice their anger over a law that discriminates on the basis of religion which the Constitution expressly forbids. The law provides for asylum to outsiders from Afghanistan, Bangladesh and Pakistan except for Muslims.

These are some of the questions I have:

- Why is the Act specifically leaving out Muslims, when they are a large minority, have been part of our country's history for centuries, and have contributed significantly to its ethos in multiple ways? We have had Muslims occupying Rashtrapati Bhavan in Delhi as president, and Muslim vice-presidents; the community has seen its members serve as distinguished ministers, freedom fighters (I have seen Maulana Abul Kalam Azad in my childhood) judges, artists (M.F. Hussain, Raza and others), musicians (several ustads who were honoured as distinguished role models – from Ustad Amir Khan to Bade Ghulam Ali Khan, Tarana Samrat Ustad Nissar Hussain Khan, to name just a few); defence personnel, academics, you name it, you find Muslim names as high achievers and leaders. Can we meddle with the promises made under our Constitution that forbids discrimination on the basis of religion?

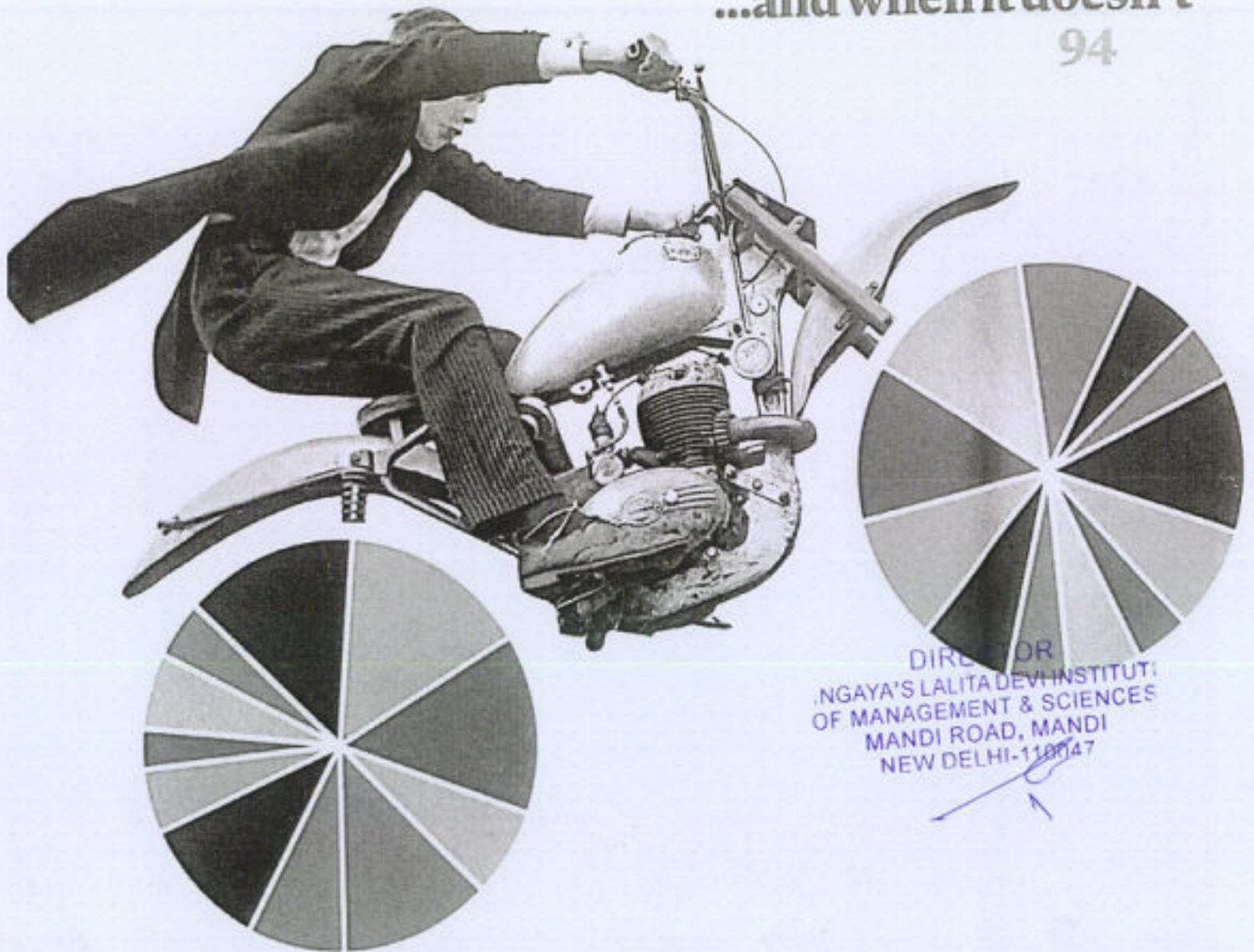
